<b>51-14 The camp operator has not ensured that a director or director's designee is present at the camp or, when the activity occurs off the camp premises, the activity site, violating COMAR 10.16.06.51 and COMAR 10.16.06.52.*</b>		
<b>51-15 The camp operator has not ensured that an instructor is present at the specialized activity, violating COMAR 10.16.06.51 and COMAR 10.16.06.52.*</b>
